

Call for Entry: Drawn to Nature Entry deadline: September 16, 2024 Exhibition: October 13-November 9, 2024

Art can help us become more conscious of our true relationship with nature. JRAC's Drawn to Nature exhibition is an opportunity to express your personal connection to nature. How does the natural world inspire and influence you as an artist? Whether your art is developed from organic materials, delves into conceptual realms of nature's essence or seeks to raise awareness and inspire action, we look forward to your interpretations and reflections on this theme. All media are welcome in the areas of 2D, sculpture, vessels, installations and other formats.

**Entry:** The entry deadline is September 16, 2024. Artists are encouraged to submit their entries online at jordanriverarts.com. Alternatively, a PDF may be downloaded from the website and sent by email. The JRAC Exhibitions Committee reserves the right to the final selection of work to be shown in the gallery; space limitations may apply.

**Photo Requirements:** An overall image and up to one detail image are required for all works submitted. Photos are used for exhibit planning and promotional purposes.

**Artwork Delivery:** Work must be gallery-ready when submitted. Paintings and other 2D pieces should be finished, dry and include the approved installation device, which is gallery wire. No saw tooth hanging hardware please. All work must be labeled to include title, artist name, medium, size, and sale price if available for purchase. A completed Inventory Form must also be included (available on the web page for this Call).

**Fees:** Entry is free for JRAC members. A fee of \$15 is payable by non-members or become a member! In cases where works are offered for sale, the JRAC commission agreement is 70% to artist and 30% to JRAC. These fees help to support exhibitions and other programs at JRAC.

## **Artist Agreement**

Please review the terms and indicate your agreement by signing below.

JRAC's mission is to support the arts in our community, and one way we do that is by providing exhibiting artists with a 70% commission on all sales; 30% goes to JRAC's operating funds. If you would like to donate an additional percentage to JRAC, please indicate that on your inventory form when you deliver your artwork.

Sales are calculated monthly and payments are made in a timely manner. Payments are made by check and mailed to the artist.

It is the artist responsibility to ensure all works delivered to JRAC for display or consignment are accurately documented with a completed inventory form. Submit one copy with work and retain a copy for your files.

All work will be handled in a professional manner. All works are submitted at owners' risk and /or are covered by the owner's insurance. JRAC's insurance is limited to fire and theft (shoplifting) for the cost of materials only.

You also certify that you have full rights over the piece of work that you are putting on consignment with JRAC.

Artwork left at the Gallery for more than one year, without any response from the artist, becomes the property of JRAC.

Unless otherwise indicated with check-mark below, you are granting permission for JRAC to use your name and images/videos of your work for promotional purposes such as on the website, social media, newsletters, etc.

This agreement is valid in perpetuity, or until the artist revokes permission or a new agreement is signed.
